All candidates appearing in the **HSLC/AHM Examination, 2018** would be **Regular Candidates**.

The following are to be noted in connection with **re-admission** for the current year:

2. Candidates may take re-admission in the same School/Madrassa from where they appeared **HSLC/AHM Examination, 2017 but failed.**
2. **Re-admitted** candidate will have to appear with the same Registration Number.
3. School/Madrassa where the candidates will take **re-admission** will make arrangement for assessment of practical of the candidates for the period of study and practical marks/internal assessment will be required to be sent accordingly.
