This is for information of all concerned that the candidates who failed in the HSLC/AHM Examination, 2019 and came out unsuccessful of HSLC/AHM Compartmental Examination 2019 and desire to appear in the HSLC/AHM Examination, 2020 will be required to take re-admission in schools/madrassas. All candidates appearing in the HSLC/AHM Examination, 2020 would be Regular Candidates.

The following are to be noted in connection with re-admission for the current year:

1. Schools should give re-admission to the failed students in the same schools/madrassas from where they appeared HSLC/AHM Examination, 2019.
2. All re-admitted candidates will have to appear in the present course only (New Course). There will be NO OLD COURSE in the HSLC/AHM Examination, 2020. Re-admitted candidates will be allowed to appear with the same Registration Number.
3. School/Madrassa where the candidates will be given re-admission will make arrangement for assessment of practical of the candidates for the period of study and practical marks/internal assessment will be required to be sent accordingly.
4. Head of the Institution will supervise their attendance in Class and also their progress in the studies and include them in the Remedial class according to their need.
5. Head of School/Madrassa shall complete re-admission process on or before 31st August, 2019.
