It is notified for information of all concerned that the fee structure of the candidates who are going to appear in the ensuing **HSLC/AHM Examination, 2021** noted below: -

- 1) Examination fee : **Rs. 650.00** (Rupees Six Hundred Fifty) only.
- 2) Centre fee **Rs. 300.00** (Rupees Three Hundred) only.
- 3) Practical Examination fee **Rs. 150.00** (Rupees One Hundred Fifty) only.
(If applicable)
- 4) Annual Recognition fee **Rs. 800.00** (Rupees Eight Hundred) only.
(To be paid by Head of Institution)

As per the instruction of the Govt. of Assam, vide notification No. PMA(S) 25/2017/120 dated 22/08/2019 for the candidates whose parental income is **2 Lakhs** or below of the Govt/Provincialised and Recognized Venture School, the payment of fee is exempted provided that:-

- i) The Guardian/Parent of the candidate filed an application before the Head of the Institution for such exemption along with the documentary proof about his/her income/category.
 - ii) The applicant has to give a photograph of present status of the tree planted by him/ her at the time of admission in class IX.
 - iii) The Head of Institution must verify the genuineness of the documents submitted by the Parent/Guardian/Student before allowing the exemption form for payment of examination fee.
- A) It has come to the notice that some of the schools have registered the name of candidate in their school, although the candidate is studying in another school. The exemption of fee, for such students is not allowed, even if he/she belongs to low income category. If any exemption is granted to such candidate, and it is noticed at later stage, the result of the candidates shall be withheld and necessary action shall be taken against the Head of the Institution.
- B) The Centre fee **@Rs. 300.00** (Rupees Three Hundred) only per candidate shall be released by Board of Secondary Education, Assam to each of the centre in advance. In the portal of the examination, the centre-in-charge has to provide the Bank details of the examination account of the centre for release of centre fees.

- D) Online Examination Portal will start from **2nd November, 2020 to 23rd November, 2020**.
