NOTIFICATION

It is for information of all concerned that the fees structure of the candidates who are going to appear in the ensuing **HSLC/AHM Examination, 2022** is noted below:-

1. Examination Fee : **Rs 650.00** (Six hundred fifty only)
2. Centre Fee : **Rs 300.00** (Three hundred only)
3. Practical Examination Fee : **Rs 150.00** (One hundred fifty only)
(If applicable)
4. Annual Recognition Fee : **Rs 800** (Eight hundred only)
(To be paid by the Head of the Institution)

As per the instruction of the Govt. of Assam vide Notification no. PMA(S)25/2017/120 dated 22/08/2019 the payment of fee is exempted for the candidates of Govt/Provincialized and Recognized venture schools whose family income from all sources is **2 lakhs or below** per annum, provided that,

1. The Guardians/Parents of the candidate has to file an application before the Head of the Institution for such exemption.
 2. The applicant has to give a photograph of present status of the tree planted by him/her at the time of admission in class IX.
 3. The Head of the Institution must verify the genuineness of documents submitted by the Parents/Gurdians/Students before allowing the exemption of Examination fee.
- A. Candidate will be allowed to complete their form fill-up from their parent School only, where their Class IX Registration has been done. No candidate will be allowed to form fill-up from another Institution, if their Registration has not been transferred yet.
- B. The Centre Fee @ **Rs 300.00** (Three Hundred only) per candidate shall be released by the Board of Secondary Education, Assam to each of the Centre in due course. In the Examination portal the Centre-In-Charge has to provide the Bank details of the Examination account of the Centre for release of Centre fees.

- D. Online Examination portal will start from **25th Nov, 2021 to 18th Dec, 2021**.
- E. The candidates who have not appeared in the **Half Yearly Examination** of Class X, held in the month of October, 2021, **shall not be eligible** to sit in the HSLC/AHM Examination, 2022.
