NOTIFICATION NO. SEBA/EX/HOLD/42/2018-19/

Dated, Guwahati, the 8th October, 2018

- A) In accordance with the decision taken in the **Board Meeting held on 06/10/ 2018** of the Board of Secondary Education, the Examination fee for the HSLC/AHM Examination , 2019 shall be as under :
- 1) **Examination fee** - Rs. **650/-**(Rupees Six hundred fifty) only. (per candidate)
 - 2) **Centre fee** - Rs.**300/-**(Rupees Three hundred) only. (per candidate)
 - 3) **Practical Examination fee** - Rs.**150/-**(Rupees One hundred fifty) only. (per candidate)
 - 4) **Annual Recognition fee** -Rs.**800/-**(Rupees Eight hundred) only. (per School)
- B) As per the instruction of the Govt. of Assam, for the **BPL candidates** of the Govt./Provincialised and Recognised Venture School, the payment of fee is exempted, provided that :-
- (i) The Guardian/Parent of the candidate filed an application before the Head of the Institution for such exemption, along with the documentary proof about his/her BPLCard/Category.
 - (ii) The applicant has to give a photograph of present status of the tree planted by him at the time of admission in class IX.
 - (iii) The Head of Institution must verify the genuineness of the documents submitted by the Parent/Guardian/Student before allowing the exemption form for payment of examination fee.
- C) It has come to the notice that some of the schools, have registered the name of candidate in their school, although the candidate is studying in another school. The exemption of fee, for such students is not allowed, even if he belongs to BPL category. If any exemption is granted to such candidate, and it is noticed at later stage, **the result of the candidate shall be withheld and necessary action shall be taken against the Head of the Institution.**
- D) **The Centre fee @Rs 300/-** (Rupees Three hundred) only per candidate shall be released by Board of Secondary Education, Assam to each of the centre in advance. In the portal of the examination, the Centre-in-Charge, has to provide the **bank details** of the examination account of the centre for release of Centre fees.
